I am pleased to notify you that all state canoe/kayak associations are invited to send their teams to this first ever sea kayak event scheduled for OCTOBER  $16^{th}$  –  $20^{th}$  2024.

A sporting and historical territory located in the **Tuticorin aka Thoothukudi** region of Tamil Nadu, the most beautiful city is happy to host the National Sea Kayak & Stand-Up Championship. Tuticorin is also known as the **"Pearl City"** and the **"Modern Port City."** The city lies 40 km east of Tirunelveli on the Gulf of Mannar in the Bay of Bengal.

Water sports have always been a main attraction here, and the city has a lot to offer, from enthralling temples to beautiful beaches, making it a perfect place for water sports lovers.

Thoothukudi has a fascinating history. Thoothukudi remained in Chola hands, and its maritime port attracted traveller's, adventurers, and, eventually, colonizers. The Portuguese were the first to arrive in Thoothukudi in 1932 A.D., followed by the Dutch in 1658 A.D. The English captured Thoothukudi from the Dutch in 1782, and the East India Company established their control over Thoothukudi in the same year.

Thoothukudi became the citadel of the freedom struggle in the early 20th century. It was in Thoothukudi that the illustrious patriot, V.O. Chidambaram, established the first Swadesi Stream Navigation Company, sailing the first steamer, S.S. Gaelia, to Thoothukudi on June 1st, 1907.

Our association is preparing the necessary accreditation and accommodation arrangements to facilitate the technical delegate. # **HOW TO REACH THE VENUE**

- 1. By Air-The **Tuticorin Airport is at Vagaikulam**, 14 km (9 mile) from the heart of the city. The domestic airport is quite developed and connected to prominent cities of India.
- 2. By Rail- **Thoothukudi** Railway station comes under Southern Railway Division, connected with Chennai, Mysore, Coimbatore, Okha and Tirunelveli. It is well-connected to major cities. However, direct trains from northern states might not be available to Tuticorin.


## **IMPORTANT POINTS:**

- \* ALL THE ATHLETES ARE REQUIRED TO CARRY THEIR PHOTO IDS SHOWING PROOF OF AGE (MANDATORY)



# 1. INFORMATION

#### **Insurance and Medical Care Insurance**

The Organizing Committee will take reasonable steps to ensure the safety of the property of teams and visitors at the venue but accepts no responsibility for loss of or damage to such property, however caused. Likewise, the Organizing Committee will take reasonable steps to ensure the safety of persons at the venue but accepts no responsibility for injury to such persons. It is the responsibility of visiting teams to ensure that they have adequate insurance to cover their own persons and property.

It is a requirement for teams to have insurance in force to cover their legal liability for injury to other persons or damage to their property, in relation to both on and off water activities.

All participants are strongly advised to take out a medical insurance policy in the irrespective States & Units

#### Medical care

The following medical services are available for all official participants of the event: Physician on duty, Physiotherapist, Hospital and Clinic assistance. A medical Centre will operate course with ambulance and first aid. All costs above the regular medical care have to be covered by the medical insurance policy. The Organizing Committee does not take responsibility for such expenditures.

# 2. ENTRIES DETAILS

# **Entry Fees:**

Each state association and unit, the Services Sports Control Board, the BSF, the ITBP, the All-India Police Control Board, the C.R.P.F., and the Indian Navy Sports Control Board may enter one or more teams.

# **Details: (INR)**

- \* **Registration Fees:** (500/-per head/per boat for Sea Kayak and Rs. 500/-per head/per boat for Stand-Up Paddling)
- \* **Federation Fees:** 500/-Per Person will be charged as Federation fees and all paddlers and officials are required to be registered to enable them to participate.
- \* **Technical Charges -** There will be technical rescores and technical arrangements (IT arrangements) charges of Rs. 1000/-for Senior Men & Women.
- \* **Inflation Fees** IKCA will charge only inflation fees of Rs. 1300/-per head, out of which Rs. 1000/-will go to IKCA and Rs. 300/-will go to the organising committee.
- \* Inflation to cover the expenses of Accreditation, Medical Care, participation in functions, security services, lifesaving, Motor Boat, laying of course, chest number, drinking water at the venue, etc.
- \* Only paddlers who are registered and have accreditation cards from the IKCA will be allowed in the championship.



# 3. Equipment

- \* Athletes have to bring their own Boat, Paddle, life Jacket, Helmet, Spray deck, and other personal items.
- \* Boats can be given on rental charges of Rs. 500/-per head and Rs. 500/-per boat parking for those who bring their own.
- \* Athletes' lives are the responsibility of both the athlete and the state.

# Keeping in good shape

It is recommended that paddlers stay hydrated carefully, wear protective clothing and remain under shelter as much as possible.



# Athletes' Whereabouts (Towards Clean Sports) Data will be collected via Google Forms.

A link will be shared with the registered athletes.

- Home address, email address and phone number
- An address for overnight accommodations
- Regular activities, such as training, work, and school, the locations and the times of these activities
- Competition schedules and locations
- A 60-minute time slot for each day where they'll be available and accessible for testing and liable for a potential 'missed test.



**COVID-19 Advisory** 

#### PRECAUTIONARY MEASURES AT THE VENUE:

Entry points of athletes' area Signage should be displayed with recommended health checks prior to entry.

Temperature checks on entry are not mandatory and we encourage all those accessing the venue to isolate and report if feverish or experiencing other symptoms of covid 19 infection.

#### Face masks

All accredited persons must wear a face mask indoors except when eating, drinking or exercising (dry land warm-up, warm-down and recovery from competing). The face masks must be worn over the mouth and nose to be most effective.

## **Hand sanitizers**

Alcohol-based hand sanitizer will be available at multiple locations around athletes' area, finish tower and other places such as at the entry points of the athletes' area, eachbuilding and room, boatsheds, team rooms/tents, dining area, sanitary facilities, etc.

# Social distancing measures

Social distancing should be respected. The recommended minimum distance between people is 1.5m for indoor area and 1m for outdoor area.

All persons attending the competition should avoid close contact such as handshakes and embraces.

# Cleaning and sanitizing

Regular disinfectant cleaning and sanitizing the premises are the fundamental actions that, together with interpersonal distancing, can avoid the spread of the virus.

All participants will be made aware of the importance of complying with the rules of hygienic-sanitary behavior to help maintain the maximum cleanliness and healthiness of shared environments.

Each participating State Federation will be expected to have undertaken their own risk assessment, have a Covid 19 safety protocol in place and to have taken appropriate precautionary measures prior to travel.

Each participating State Federation is responsible for all costs (including medications) should any member of their team be required to go into quarantine at any time from arrival to departure and/or be hospitalized or to return to the city of departure.

## It is advisable to be vaccinated with both doses.

Each participating State Federation is responsible for all costs associated with Covid-19 testing prior to arrival if required by the respective travel authority.
